CMAA/TCM Code 17

Program Planning & Policy Development for All Clients:

Performing activities around & developing strategies to increase Medi-Cal system capacity and close Medi-Cal service gaps; including analyzing data related to a specific program or group, interagency coordination to improve delivery of Medi-Cal services or developing directories of Medi-Cal services/providers.

Q: When can I use Code 17?

A: Any time you are working to "close the gap" or improve health care services.

Q: I'm not a manager, can I claim Code 17?

A: Yes! Anyone who is identifying needs or increasing health care services to clients is performing PP&PD.

Q: Can I use Code 17 for the creation of an email banner?

A: Yes! The time discussing and creating your banner (or newsletter or flier) is Code 17.
