Overview

Many of the facilities listed here accept patients suffering from dementia. Some have activity directors and accept patients suffering from incontinence. The following pages list care facilities in Santa Cruz and San Benito Counties and are broken down according to areas.

In each section, **Residential Care Facilities** are listed first; early-stage Alzheimer's patients are unlikely to need skilled nursing care. Second are **Skilled Nursing Facilities**, where medical attention plays a major role in the treatment of the patients; all such facilities accept Alzheimer's patients. The Santa Cruz County section also has **Post-Hospital Care Facilities**, where patients can receive intense treatment for a limited amount of time and a **Locked Psychiatric Facility**.

Alzheimer's Association volunteers, based on a questionnaire and sometimes an interview with a staff member in each facility assembled these materials. These are rough data that are subject to change at any time. The Alzheimer's Association is not responsible for any inaccuracies.

None of this information is meant to reflect either negatively or positively on any facility. This information was provided to us by the facilities, and we have edited only for the sake of coherent presentation. We urge you to use this data only as a starting place to begin looking at facilities.

Here are some tips in selecting a facility:

- Become familiar with the options. The association office, phone (831) 464-9982, has copies of the booklet "Family Guide for Alzheimer's Care in Residential Setting". This valuable brochure includes information on payment considerations- Medicaid, Medicare, private insurance, personal resources as

well as a checklist to use when visiting and evaluating facilities. Also a "Guide to Choosing a Nursing Home: Quality Care Issues" is free from Senior Network Services' HICAP Program, phone (831) 462-1433.

- Call the Ombudsman/Advocate, phone (831) 429-1913 or (831) 688-8833 to see if there are complaints against the facilities they are considering.
- Ask for and negotiate for what you want. Some facilities that do not accept SSI (Social Security Income) in full payment may accept it if a supplement is added.

Additional materials relating to facilities addressed in this section are in the Alzheimer's Association office. These include a file for each facility and a map showing each facility location. Various materials are in these files, including (for some, not all), a promotional brochure, photos, an activity program, and a menu of meals. Sometimes people familiar with the facility have added their comments on a comment sheet.
