3. August 14, 2024, Meeting Minutes - Action Required

Review of August 14, 2024, Meeting Minutes – Recommended for Approval. It was noted by one of the commissioners that the action items were not listed to agenda, Mary will add to agenda. Rahn motioned to accept minutes as amended. Len second, and the rest of the members present were all in favor. Christina abstained as she was not present at that meeting.

4. FQHC Report

Amy gave a Federally Qualified Health Center (FQHC) overview. An FQHC is a primary care clinic that receives federal funding to provide healthcare services to underserved communities. They provide primary care services regardless of a patient's ability to pay and offer sliding scale fees based on a patient's ability to pay. Amy reported HRSA came in 2014 to conduct our first site visit. The Health Centers received a grant from HRSA in 2015 to open the Watsonville Health and Dental Center and the addition of IBH services. In 2016, we submitted a Chang in Scope to HRSA to add 330(e) to our scope. Additional grants were secured in 2016 and 2017 to implement the Medication Assistance Treatment. In 2021, the Homeless Persons Health Project received funding to purchase a mobile health unit for street medicine. Amy reported the grant amounts received for these grants totaled \$7,283,919.00. Amy stated there are only three FQHC centers in our area which are County of Santa Cruz, Santa Cruz Community Health Centers, and Salud Para la Gente. Lastly, Amy reported what makes our FQHC different as a public entity is the use of EHR at Juvenile Hall, Behavioral Health & Public Health, FQHC billing for Behavioral Health, no philanthropic fundraising, MediCruz & Access to Care for all safety-net clinics, HIV & TB Care for the community, employees as disaster service workers, and a safety net for Public Health.

5. Quality Management Update

Raquel reported Emeline Health Center presented this month's quarterly quality improvement. Emeline Clinic reported on well-child visits and increasing visits. Raquel stated they are working with the Alliance to reassign patients if they have been seeking services at another FQHC. Raquel also reported they received data from HRSA on the Workforce Wellbeing Survey that was conducted last year in January of 2023. She stated a dashboard for the data was created from the results of the survey. Raquel stated a subcommittee has been established to review results of survey. Raquel also reported they had finalized the staff satisfaction survey which was sent out in the middle of August to the end of August, she will come back and share results. Raquel stated the Ryan White-Patient Satisfaction Survey had been sent out and will review the results next month. Lastly, Raquel reported on Peer Review & Risk Management Committee. She stated peer review had worked on the Peer Review Policy, and they are about halfway through, and she will bring back to commission once it is finalized. She also reported they are bringing forward complaints and grievances as a team. She stated they will be doing a high-level overview and come up with common themes of grievances to bridge with all the clinics to help improve in those areas.








