#### **BIRTH CERTIFICATE SUMMARY & HIGHLIGHTS**

This year 2000 Birth Certificate Summary Report includes all births to Santa Cruz County residents (3,480) and 351 births to women who live in other counties but delivered in Santa Cruz county. Of the county residents who gave birth, 232 delivered outside of the county and the indicator data concerning their births is shown in the "Out of County" column in Tables 1 and 2. The 351 non-county residents' birth data included in this report are interspersed among the 3 delivery facilities in the county; 175 of these births are to Monterey County residents living in zip code 95076.

#### HIGHLIGHTS OF HEALTH INDICATORS FOR 2000:

- ♦ 88% of all women in 2000 received prenatal care in the first trimester. This rate continues to rise slowly, is higher than the 84% seen in 1999, and is still higher than the 82.2% statewide. However, among women whose births were covered under Medi-Cal, the early-to-care rate did not increase from the 1999 rate of 73%. The Year 2000 Goal for the State of California was 90%. Entry into care in the third trimester continues to remain low at 1.8%, and only 21 birth certificates indicated "no prenatal care". Only 2% of the women received inadequate care according to Kessner index.
- ◆ Low birth weight (under 5.5 pounds) babies continue at a steady, low level of 5.2%, below California's 6.1% and nearly equal to the Year 2000 goal of 5%. Teens show an 8.4% rate of low birth weight with a larger proportion of the babies under 1500 gms. (3.3 pounds) than the general population. These numbers remain quite small, however, with only 34 babies under 1500 grams for the total county's births.
- Medi-Cal births have continued on a downward trend, at 41% of the total births in Santa Cruz County. Medi-Cal births peaked at 51% in 1994. Watsonville Community Hospital's Medi-Cal deliveries remain at 70% of their total number of deliveries, and this hospital delivers 67% of the county's Medi-Cal funded births. A new table has been added this year for Medi-Cal births by zip code that displays 95076 and 95019 (south county) which account for 70% of all Medi-Cal births in the county.
- ♦ Births to women age 35 years and older account for 19.8% of all births in Santa Cruz County. This is higher than the statewide average of 15.6% (in 1999).
- ◆ The raw number of births to teens 19 years and under holds steady at 9.7% of the total births in the county. Teen birth *rates* reflect the same picture with a 2000 rate of 40.4 (per 1000 population estimate) comparable to 1999. Analysis of the raw number of births to teens shows an overall drop of 22% from 1995 to 2000, with the largest decrease of 60% for ages 16 and under. Of the 371 births to teens 19 years and under, 242 of the (65%) were to residents of 95076, and 60 were the 2<sup>nd</sup> birth (or more) for the teen. This represents 16.2% of total births to teenage mothers, much lower than the national average of 22% (in 1998). In comparison to the total birthing population, teens had higher rates of inadequate care, late and no prenatal care, and low birth weight babies.
